Product description

Silirub NO5T is a neutral, low odor, high quality façade and glazing sealant, compliant with ISO 11600 F&G 25LM.

Properties

- Very easy to apply

Applications

- All usual building joints with high movement.
- All glazing and joint works.
- Expansion joints between many different construction materials.
- Sealing between PVC, treated wooden and metal profiles and glass.

Packaging

Colour: transparent Packaging: 300 ml cartridge

Shelf life

15 months in unopened packaging in a cool and dry storage place at temperatures between $+5^{\circ}$ C and $+25^{\circ}$ C.

Substrates

Substrates: all usual building substrates Nature: clean, dry, free of dust and grease. Surface preparation: Porous surfaces in water loaded applications should be primed with Primer 150. No primer needed for non-porous substrates.

There is no adhesion on PE, PP, PTFE (Teflon®) and bituminous substrates. We recommend a preliminary compatibility test. This is highly recommended on PVC and other plastics.

Joint dimensions

Min. width for joints: 5 mm *Max. width for joints*: 30 mm *Min. depth for joints*: 5 mm Recommendation sealing jobs: joint width = 2 x joint depth.

Application method

Application method: With manual- or pneumatic caulking gun. Cleaning: Clean with white spirit or Surface Cleaner immediately after use. Finishing: With a soapy solution or Soudal Finishing Solution before skinning. Repair: With the same material

Health- and Safety Recommendations

Take the usual labour hygiene into account. Consult the packaging label for more information.

Remarks

- Do not use on natural stones like marble, granite,...(staining). Use Soudal Silirub MA or Silirub+ S8800 for this application.
- Direct contact with the secondary sealing of insulating glass units (insulation) and the PVB-film of safety glass must be avoided.
- The implementation of insulating glass and carpentry work must comply with the DTU39 and the recommendations made by the organizations SNJF and CEKAL.
- A total absence of UV can cause a color change of the sealant.
- In an acid environment or in a dark room, white silicone can slightly turn yellow. Under the influence of sunlight it will turn back to its initial colour.
- When finished with a finishing solution or soapy solution, make sure that the surfaces are not touched by this solution. This will cause the sealant not to adhere to that surface. Therefore we recommend to only dip the finishing tool in this solution.
- We strongly recommend not to apply the product in full sunlight as it will dry very fast.
- Do not use in applications where continuous water immersion is possible.
- Do not use on polycarbonate. Use Silirub PC or Silirub AL instead.
